

INTRODUCTION

We plan to take advantage of the aging population of Central Europe, to build a unique WELLNESS AND ENTERTAINMENT CENTER located right at Klopeiner See lake in the municipality of St. Kanzian, Austria.

This lake is a perfect location; water is 33% warmer than other lakes in the region and it's drinking quality. It's surrounded by beautiful mountains with exciting trails with a variety of outdoor activities for families and adults.

The WUND Group www.wund.de was responsible for the execution of the feasibility study. They successfully operate five comparable facilities and they have agreed to be the operator of this unit. The average annual number of visitors for similar size facilities is 733,333 and the average annual EBITDA is 8.96m euro. For the St. Kanzian project the WUND GROUP estimated an average of 525,000 visitors per year and 6.2m euro of EBITDA, for the first ten years of operations.

This facility will include a 300-bed hotel, natural thermal waters, over 400 genuine Caribbean palms, turquoise lagoons with pool bars, unique sauna attractions, soothing mineral and wave pools, high tech slides and a variety of exclusive SPAs. Over 10,000 sqm of premium leasable space will be built for food, beverages, cosmetic, fashion and health-related services.

The PORR GROUP https://porr.at/en/ is the preferred EPC contractor with extensive experience in this type of project and PICHLER https://pichler.pro/de/referenzen will be responsible for the architectural design.

St. Kanzian's municipality is providing the land and is guaranteeing the receipt of all permits, not later than 9 months after detailed engineering work begins.


The St. Kanzian Wellness Center will offer:


WE SEEK TO RAISE 77.6 MILLION EURO


After commissioning is done, the Austrian government will provide a subsidy of 8.6m €.

Developer already has received the donation of the land for the project and has options to acquire additional hectares at a competitive price.
